Privacy Policy

Your privacy is critically important to us. At K-Customers.com we have a few fundamental principles:

- **We don't ask you for personal information unless we truly need it.**
- **We don't share your personal information with anyone except to comply with the law, develop our products, or protect our rights.**
- **We don't store personal information on our servers.**

Below is our privacy policy which incorporates these goals. If you have questions about deleting or correcting your personal data please contact our support team.

Website Visitors

Like most website operators, K-Customers.com collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. K-Customers.com's purpose in collecting non-personally identifying information is to better understand how K-Customers.com's visitors use its website. From time to time, K-Customers.com may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

Gathering of Personally-Identifying Information

Certain visitors to K-Customers.com's website choose to interact with K-Customers.com in ways that require K-Customers.com to gather personally-identifying information. The amount and type of information that K-Customers.com gathers depends on the nature of the interaction. For example, we ask visitors who contact us to provide a name, phone number and email address. Those who engage in transactions with K-Customers.com – by purchasing Kyani products, for example – are asked to provide additional information, including as necessary the personal and financial information required to process those transactions. In each case, K-Customers.com collects such information only insofar as is necessary or appropriate to fulfill the purpose of the visitor's interaction with K-Customers.com. K-Customers.com does not disclose personally-identifying information other than as described below. And visitors can always refuse to supply personally-identifying information, with the caveat that it may prevent them from engaging in certain website-related activities.

Aggregated Statistics

K-Customers.com may collect statistics about the behavior of visitors to its websites. K-Customers.com may display this information publicly or provide it to others. However, K-Customers.com does not disclose personally-identifying information other than as described below.

Protection of Certain Personally-Identifying Information

K-Customers.com discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organizations that (i) need to know that information in order to process it on K-Customers.com's behalf or to provide services available at K-Customers.com's website, and (ii) that have agreed not to disclose it to others. Some of those employees, contractors and affiliated organizations may be located outside of your home country; by using K-Customers.com's website, you consent to the transfer of such information to them. K-Customers.com will not rent or sell potentially personally-identifying and personally-identifying information to anyone. Other than to its employees,

contractors and affiliated organizations, as described above, K-Customers.com discloses potentially personally-identifying and personally-identifying information only in response to a subpoena, court order or other governmental request, or when K-Customers.com believes in good faith that disclosure is reasonably necessary to protect the property or rights of K-Customers.com, third parties or the public at large.

If you are a customer of the K-Customers.com website and have supplied your email address, K-Customers.com may occasionally send you an email to tell you about new promotions, solicit your feedback, or just keep you up to date with what's going on with K-Customers.com and our products. We primarily use our various product blogs to communicate this type of information, so we expect to keep this type of email to a minimum. If you send us a request (for example via a support email or via one of our feedback mechanisms), we reserve the right to publish it in order to help us clarify or respond to your request or to help us support other users. K-Customers.com takes all measures reasonably necessary to protect against the unauthorized access, use, alteration or destruction of potentially personally-identifying and personally-identifying information.

Cookies

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. K-Customers.com uses cookies to help K-Customers.com identify and track visitors, their usage of K-Customers.com website, and their website access preferences. K-Customers.com visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using K-Customers.com's websites, with the drawback that certain features of K-Customers.com's websites may not function properly without the aid of cookies.

Business Transfers

If K-Customers.com, or substantially all of its assets, were acquired, or in the unlikely event that K-Customers.com goes out of business or enters bankruptcy, user information would be one of the assets that is transferred or acquired by a third party. You acknowledge that such transfers may occur, and that any acquirer of K-Customers.com may continue to use your personal information as set forth in this policy.

Ads

Ads appearing on our website may be delivered to users by advertising partners, who may set cookies. These cookies allow the ad server to recognize your computer each time they send you an online advertisement to compile information about you or others who use your computer. This information allows ad networks to, among other things, deliver targeted advertisements that they believe will be of most interest to you.
